## Legislators' Brunch Looks to Past, Present, Future

This year's Legislators' Brunch, held March 4 at Kathy Fennelly's home, hosted a full complement of Arlington legislators — one of whom no longer represents Arlington, and another of whom will no longer represent Arlington a year from now.



Will Brownsberger won a special election to become a State Senator representing Belmont, Watertown, and parts of Cambridge and Boston. Since his Arlington precincts (2 and 4) will have no representation until after the fall election, he is continuing his involvement with the Town and helping with constituent services where he can.

Because of redistricting, Jay Kaufman, too, will no longer represent Arlington next year. Both he and Sen. Brownsberger spoke of the excellent teamwork among Arlington's four legislators in the past, and their expectation that they will all continue to work together well in the future.

Sen. Brownsberger, Rep. Kaufman, Sen. Ken Donnelly, and Rep. Sean Garballey all spoke about issues they were focusing on, and then answered questions from League members and guests.

Sen. Donnelly began by paying tribute to his fellow legislators, noting that Sen. Brownsberger is now Senate Chair of the Joint Committee on Public Service, while Rep. Kaufman is House Chair of the Joint Committee on Revenue, and Rep. Garballey is Vice Chair of the Joint Committee on Election Laws.

Rep. Kaufman said that he was somewhat hopeful about the possibility of revenue reform, because a special commission is likely to recommend changes in tax expenditures, the special exceptions to taxes that cost the state \$26 billion in revenue. Many exceptions are desirable (the sales tax exemptions for food and clothing, for example), but others are not. Reducing these by just 10% would resolve the current budget shortfall.

## Legislators' Brunch (Continued)

Rep. Garballey, the House chair of the MBTA caucus, reported that he has been focusing his efforts against the T's proposals of significant service cuts and fare increases. He is also a co-chair of the caucus on public higher education, which has suffered severe cuts over the past decade.

The legislators then answered questions on the following topics, among others:

**Tax Revenues:** According to Rep. Kaufman, revenue has fluctuated, because the recovery has been uneven. Sen. Donnelly noted that revenues were lower than expected in 2012 by about \$100 million so far. The structural deficit remains, federal cuts are likely (in Medicaid, for example), and tax increases are unlikely in the current climate.

**Bottle Bill Expansion:** Sen. Donnelly said that because the House Speaker does not support this proposal, it is unlikely to pass, though it is very popular; as Rep. Kaufman noted, the public is ahead of the leadership on this issue. Rep. Kaufman recommended that citizens talk to their representatives and make their views known. [Note: See page 10 for a State League Action Alert on this issue.]

**Three Strikes Bill:** Patti Muldoon observed that we spend more money on prisons than on higher education, and asked about prospects for reducing rather than increasing the prison population. Sen. Brownsberger replied that he had some hopes for a comprehensive Senate crime bill that combined some habitual offender language with a reduction of mandatory minimum sentences. This could replace a narrower House bill that might lead to more rather than fewer long sentences. He noted that with mandatory minimums, an offender's sentence is determined not by the judge and jury, but by the prosecutor's decision on what crime to charge the offender with.

**Election Laws:** Rep. Garballey said that a bill that included audits, pre-registration for high-school students, and other provisions would be coming up soon. Rep. Kaufman noted that there is a movement for a vote in the House to ask our congressional representatives to support a constitutional amendment to counteract the Supreme Court's Citizens United decision, which allowed unlimited political spending by corporations and unions; the real fix, he commented, would be public financing of campaigns. Rep. Garballey expressed concern that the effects of Citizens United might begin to be felt even at the local level.

**Belmont Uplands:** Sen. Brownsberger said that the State was unlikely to take action, and that it would be up to localities, led by Belmont, to try to purchase the land to keep it as open space.

Next year, Rep. Garballey will represent all of Arlington except for precincts 2, 4, 8, 10, and 12, which will have a new representative. Sen. Donnelly remains Arlington's Senator. Even our departing legislators, however, said they would love to come to next year's brunch if asked, that they had enjoyed their involvement with Arlington, and that they looked forward to continuing to work with their fellow legislators and with the League.

### In Memoriam: Helen Jusius

Helen Jusius, a longtime member of the League of Women Voters of Arlington (and an honorary member since 1998), died in Maine on January 19, 2012 at the age of 84. A public accountant by profession, Mrs. Jusius lived in Arlington since the early 1950s, first on Jason Street, then at the Kentwood condominium and at Sunrise Assisted Living before moving to Maine in 2011. Her husband Edvardus died in 2008; she leaves a daughter, two grandchildren, and two great-grandchildren.

Elizabeth Thompson recalls, "Every year she reviewed and verified the League treasurer's report to ensure that the League's records were accurate. I was President of the LWV Arlington in the early 1980s and got to know her then. She was a lovely, gracious lady and always told me that she was happy to perform that service for the League."

## Volunteers Needed for Cambridge Tenants Election April 10

The Alliance of Cambridge Tenants is an organization of residents who live in public housing or receive housing vouchers through the Cambridge Housing Authority. The Arlington League supervised their first election three years ago. It turned out to be a much bigger endeavor than any of us had imagined. There were over seven thousand individuals eligible to vote in a very complicated process.

But amazingly, the election went very well, so LWVA has agreed to help again for their second election to be held on April 10. The ACT by-laws require that an outside impartial organization supervise their elections. The LWVA may well be the only such organization with the experience to do so.

League volunteers are needed to supervise the polls, count the ballots and record absentee ballots:

- We will need **12** League members to supervise the six polling places from **4:30 p.m. until 6:30 p.m. on April 10.**
- We will need **6** members to count the votes at a location near Central Square from **7 p.m. until approximately 10 p.m., also on April 10.**

(We have enough people to record the absentee ballots the weekend before.)

Please take a moment to rescue the Updated Bottle Bill and help it become law this year. This bill would put a nickel deposit on bottled water, juices, teas, and energy drinks and work exactly like the deposit we already have on beer and carbonated beverages.

The Updated Bottle Bill is currently stuck in the Telecom, Utilities & Energy Committee.

The Speaker of the Massachusetts House, Robert DeLeo, has the power to move this bill out of Committee, but he needs to hear your voice loudly and clearly in favor of it.

Passage of the Updated bottle bill would:

1. Recycle one billion more bottles annually in Massachusetts - enough to fill Fenway Park to the Monster seats.
2. Create 500 new jobs at redemption centers that are in the business of recycling the returned bottles / cans. Keep 500 more recycling jobs in danger of being lost.
3. Reduce litter in cities and towns and save tax dollars spent to pick up litter
