You're Invited! Learn About the MBTA Communities Law From Jennifer Susse, LWVA Member

Come join us as we discuss the MBTA Communities Law. This law requires cities and towns served by the MBTA to increase the supply and type of housing in order to address high regional housing costs. The type of housing incentivized is sometimes referred to as "missing middle housing." These are the triplexes and small apartment buildings that Arlington used to build, before the last major zoning recodification in the 1970s.

There is a good introduction to the MBTA Communities Act on the Equitable Arlington website (<u>https://equitable-arlington.org/</u>), but very briefly the law requires 175 communities that are located near transit to create a district of reasonable size where multifamily housing is allowed by right. The final proposal is still being hashed out, but it will likely affect between 2 and 4 percent of Arlington's buildable land.

The MBTA Working Group will soon conclude its work and send its recommended proposal to Arlington's Redevelopment Board (ARB) for consideration. Then the ARB will have a series of meetings, both to refine the proposal and hear from the public. Finally, Town Meeting members will vote on a proposal at the special Town Meeting that starts on October 17th.

Directions: 97 Gray St. is at the intersection of Gray St. and Churchill Ave., which is the 4th right after you turn onto Gray St. from Pleasant St. (Route 60). If you're traveling on Gray St. from Arlington Heights, Churchill Ave. is the 4th left after the lights at Highland Ave. The house is a large gray home on the right side if you're traveling up from Pleasant Street. There is plenty of onstreet parking.

In Memoriam: Elizabeth Thompson

We were saddened to learn from Julia Thompson that her mother, Elizabeth Thompson, died on July 19, 2023. She had been living at Brookhaven in Lexington. Julia and her sister Martha were with their mother when she passed away.

Elizabeth was a member of the LWVA from 1976 until just the last couple of years. Most recently, she served as Voter Service chair.

A memorial service at her church in Winchester will take place at a future date.

Carolyn Parsons remembers, "She was President when I was doing Voter Service decades ago. She spoke a number of times against the various incarnations of the Mugar development — at Town Hall and at the Hardy School. She was an ardent environmentalist long before it became fashionable. She publicized the danger of the emerald ash borer and another worm/moth doing damage to our trees."

Meredith Zona says, "When I joined the League, Elizabeth had already served on the Board for many years, but she still remained thoroughly entrenched in Arlington League activities, and indeed throughout her life, even while she lived in Lexington for a brief period ('I couldn't switch Leagues after all this time!'). Elizabeth was always ready to pitch in, and no one was better at presenting a League position — in writing or verbally — so eloquent! The Arlington League never had a better advocate, and we who knew her benefitted greatly from her wisdom and friendship, and will always be most grateful."

Ann FitzGerald comments, "I remember how well she spoke, especially for a sound bite on ACMI for a League related event. She was smart; she also spoke about the Arlington League's history. She gave much to our chapter."

LWVMA Invites Applications for Reparations Study Committee

From the State League

A study about reparations was recommended by the LWVMA board and adopted by delegates at the 2023 LWVMA Convention in June. The LWVMA board will appoint a Study Committee to focus on this issue with a goal to finish the work over the next two years. The Study Committee will be led by Jeanne Morrison, a member of the LWVMA board and Co-President of LWV Cape Cod Area, and Susan Millinger, a member of the LWV Amherst Steering Committee. If you are interested in being considered to serve on the LWVMA Reparations Study Committee, please complete and submit THIS APPLICATION (a Google form) by September 8. LWVMA Is committed to ensuring that at least 50% of the Study Committee's members are people of color.

Reparations are a complex issue, evoking strong opinions pro and con by members of the League as well as in American society, generally. The study will consider:

- Why reparations?
- What is the history—and the present-day situation—which leads some to support reparations?
- What arguments support those who look at the same events and oppose reparations?
- Different reparations have been suggested: what are they, and what are the arguments for and against each type of reparation?
- Should the federal government provide reparations, as some argue, or should reparations be provided only by local governments or only by non-governmental bodies?
- How would a position either in favor or in opposition to reparations meet existing League positions?
- What can the work done by the Leagues of other states contribute to LWVMA's Reparations Study?

To be successful, the study must carefully consider the many pros and cons, before presenting the evidence and the arguments to the local Leagues for their consideration.

State Convention Report

Patti Muldoon and I served as delegates to the LWVMA State Convention in Worcester on June 10. We heard from League administrators: Pattye Comfort discussed initiatives to increase and diversify membership and to initiate Leagues in gateway cities such as Lynn, New Bedford, and Brockton. Delegates voted in favor of a study on reparations recommended by the LWVMA Board (see page 8).

The highlight of the convention was the keynote speech by Danielle Allen, James B. Conant Professor at Harvard University, who teaches public policy, politics, and ethics. Her initiative, Partners in Democracy (<u>https://partnersindemocracy.us/</u>), focuses on democracy renovation (not reform) on a nationwide basis. The growth of social media and decline of local news have knocked out the pillars of our democracy. Her talk was specific to Massachusetts, which has some of the least competitive elections in the country. She recommends moving from primaries to preliminary elections, like Boston's, which whittle a large candidate field down to two for the general election. This is more likely to result in positive campaigns that appeal to the whole electorate.

Allen also recommended greater transparency in the state legislature. The Massachusetts Platform for Legislative Engagement, MAPLE (<u>https://www.mapletestimony.org/</u>), makes it easy for anyone to view and submit testimony on legislative bills.

For instance, 42% of African Americans are registered to vote. This is the lowest voter registration rate for any ethnic group anywhere in the country.
